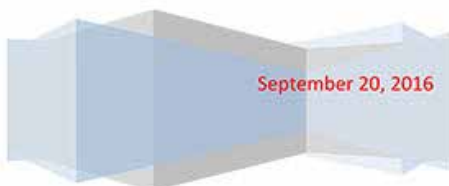
## Member Events
